RECREATION OUTPOST WILL OFFER FOUR-SEASON FUN FOR MEN AND WOMEN OF THE ARMED FORCES

Members of the military will soon have a four-season resort at their fingertips just outside of Park City, Utah.

The Mayflower Mountain Resort, owned by Extell Development Group, will combine luxury amenities with world-class recreation that is located near Jordanelle Reservoir in the MIDA Project Area of Wasatch County. Newly constructed ski lifts will provide easy access to the Greatest Snow on Earth during winter months and scenic mountain bike trails the rest of the year. The reservoir offers boating and fishing close by. When it's time to come in from the outdoors, the planned resort will include restaurants, night clubs and spas.

The purpose of the proposed MIDA project area is to provide the military with a "morale, welfare and recreation" facility or hotel — similar to other facilities

they have had around the world — in a ski-resort setting. This will be the only MIDA facility at a United States ski resort and will serve as a tribute to the men and women of the armed services.

Geneva Rock has provided 7,000 cubic yards of concrete for the Pioche Apartments, the initial phase of the project. Geneva Rock has also partnered with Jacobsen Construction and Wadsworth Brothers to provide an estimated 45,000 cubic yards for the construction of the MWR Conference Hotel that will be completed over the next couple years. Once complete, the hotel will offer 60,000 square feet of conference space and 387 guest rooms — 100 of the guest rooms being reserved for military personnel — along with 55 private residences.

Expanded Ogden yard enhances Geneva Rock's capabilities in Northern Utah

Rock has prided itself on providing more than just exceptional concrete, asphalt, aggregate, and construction services in Utah — it's held a nearly 70-year commitment to growth and innovation.

From humble beginnings in Orem, Geneva Rock quickly became one of Utah's largest suppliers of ready-mix concrete. As its presence grew along the Wasatch Front, so did its products and services — moving into sand and gravel supply, hotmix asphalt plants, and a range of construction services such as asphalt and concrete paving, utility work, and excavation and site work.

This dedication to continuously growing and developing as a company has extended to a complete overhaul of the Geneva Rock Ogden yard.
Beginning with the successful outcome of Ogden's Washington Boulevard project in 1991, Geneva Rock gradually found its way into Northern Utah. It started with plans for a concrete plant batch plant near Ogden's 20th Street around 2008,

leading to the purchase of the Ogden yard a few years later and a new office building in 2018.

That continued devotion to Northern Utah has manifested itself through a large-scale upgrade and development to the Geneva Rock Ogden yard — including the construction of new corporate offices, workshops, aggregate storage, and a full-service lab for concrete and asphalt testing.

"The Ogden yard serves more than just the Ogden area with increasing demand for products and services in the Northern Davis, Weber, and Box Elder county areas," Jay Ritchie, Geneva Rock president, says. "Those areas will soon be able to offer new and improved, state-of-the-art ready-mix and asphalt facilities. These will open up a greater ability to backup existing plants and will be a game-changer for us, the industry and our customers alike."

Ritchie is confident that having cement storage on-site, along with fly ash storage through sister company, Bridgesource,







on-site, Geneva Rock will be able to mitigate shortages, should those continue to occur.

"It gives us the ability to better control our own destiny rather than be so dependent on others for our day-to-day needs," Ritchie says. "We can take more of that responsibility on our own shoulders and be able to provide better service to our customers."

The impact of the enhanced Ogden yard will be felt throughout the Geneva Rock customer base as all handling of aggregates will be done digitally in the improved facility and aggregate piles will be stored in silos and off the ground.

"The greatest bulk of material

will go directly into these storage silos," Ritchie says. "This will minimize the number of piles that are out in the open and impacted by the elements. It'll be much more environmentally sound as everything from how the aggregates are handled to how power is distributed around the property will be managed digitally, creating efficiency and exactness."

With a full completion date of late Spring 2022, Geneva Rock's area manager for construction, Mike Westbroek, is enthusiastic and hopeful that this development will bring with it a myriad of benefits and improvements.

"It's going to be really great," Westbroek says. "It's very exciting to have all of these resources together on one site and I really think it will enhance overall productivity and, ideally, bring operations costs down."

For Ritchie, Westbroek, and the Geneva Rock teams in Northern Utah, the new and improved facilities are something that will make the Geneva Rock presence felt even more throughout the Northern Utah counties — particularly when it comes to competition.

"From a facilities standpoint, this puts us in the same ballpark as many of our competitors up in Northern Utah, but our supply improvements now move us ahead, in my eyes," Ritchie says.

UDOT-ING THE MAP

For decades, Geneva Rock has laid the groundwork for Utah's roadways with the Department of Transportation

he Utah Department of Transportation — or UDOT, as it's more commonly known — has the unique mission to Keep Utah Moving. And not just moving, but moving on cost-effective, well-built and maintained roadways.

"UDOT's role with regard to building and maintaining roadways throughout Utah includes zero fatalities, optimizing mobility, and preserving infrastructure," says Kris Peterson, director of project development at UDOT. "UDOT is responsible to safeguard the spending of taxpayer dollars in an efficient and responsible manner while

preserving the life and viability of the roadway and improving the quality of life of all who use it."

To accomplish this ambitious, multi-faceted purpose, UDOT relies on professional

partnerships with contractors like Geneva Rock.

"Geneva Rock is one of the major contractors that performs major roadway work for public and private entities throughout the Wasatch Front," Kris says.

Geneva Rock has, for decades, worked closely with UDOT on numerous projects including improvements to Interstate 15, Interstate 84 and Interstate 80. Geneva Rock has also completed work on urban thoroughfare improvements that keep the local traffic moving, too.

"Due to our longstanding business relationship, Geneva Rock is a contractor who understands UDOT's goals and objectives while delivering the quality projects UDOT demands," Kris says.

The longstanding partnership enables the two sides to work well together and finish complicated jobs with fewer delays and concerns. That is, in part, due to the numerous personal relationships that make working through inevitable issues and challenges easier.

"Individual personal relationships within our business arrangements help each part better understand the other entity's goals, objectives and needs," Kris says. "These relationships help both parties work through challenging and often difficult situations in a professional and beneficial manner."

The two parties continue to find themselves working together — primarily on heavy civil construction, asphalt and concrete paving projects — because they are aligned in their desire to complete high-quality, cost-effective work that means safer roads for Utah travelers.

Currently, there are three major road construction projects that pair the two entities. In part to better manage large, complicated projects, Geneva Rock integrated its software with the Survey123 system used by UDOT to enable for electronic communication that limits mistakes, streamlines information to the job site and uses less paper.

I-84 MORGAN TO HENEFER >>

PROJECT BREAKDOWN

- Preserves the highway infrastructure of I-84 from Morgan to Summit County Line
- Improves the concrete pavement, roadside features and structures
- Removes/replaces hot mix asphalt (HMA) on 19 bridges and deck pothole patching
- Replaces four miles of median barrier and 10 miles of highway signage

GENEVA ROCK'S ROLE

- Prime contractor on the project
- Perform concrete pavement work
- Median barrier removal and replacement
- Asphalt removal and replacement on decks

SR-150 RESURFACING >>

PROJECT BREAKDOWN

- Nine miles of lightweight chip seal and lane leveling
- Six miles of two-inch hot mix asphalt overlay with a lightweight chip seal
- The treatment is expected to last 12 years
- Project took 60 days

4100 SOUTH RECONSTRUCTION >>

- Reconstruction of existing roadway using 10 inches of granular borrow, seven inches of untreated base course and six inches of new hot-mix asphalt on two miles of arterial roadway
- Treatment is expected to last 25 years and keeps the east-west arterial roadway problem-free between 5600 West and Bangerter Highway

RECLAIMING FOR RESIDENTS

Hiking trails and extra water resources for Lehi residents highlights Geneva Rock's future housing development plan

n 2019, Geneva Rock and its development partner, GWC Capital, announced approval to build The Vistas at Point Crossing at the site of a former Geneva Rock gravel pit. The new transit-oriented development (TOD) in Lehi will turn the site into a mixed-use project with 300 luxury apartments, 100 townhome units, a high-speed bus between Utah and Salt Lake Counties, and pedestrian and bicycle paths with easy access to nearby trail systems.

As a result of this project, and through a generous donation from Geneva Rock, the city of Lehi will also see additional water and trails for its residents.

Geneva Rock will provide its own water infrastructure for the development. Geneva Rock did this by deeding a section of property to the city as a public utilities parcel that will include a one-million-gallon culinary water tank, a 2.1-million-gallon pressurized irrigation water tank and a new municipal culinary

well. The well and water storage, when completed, will not only service the new development, but will extend to residents in other parts of the city, encompassing a footprint of nearly 300 acres.

The sale was completed in the summer of 2021 and Geneva Rock immediately donated the funds to the Traverse Mountain Trails Association (TMTA), a Lehi-based organization that promotes and supports the development of local, sustainable recreational trails to help Utah residents live a healthy and active lifestyle.

"We are always excited when companies like Geneva Rock step up and do more than is required simply to benefit the larger community," says Brad Kenison, assistant city engineer with the city of Lehi. "As part of the annexation agreement with Lehi City, Geneva Rock was required to provide the water infrastructure for their development. However, they also went above and beyond to build water infrastructure for an

area larger than their proposed development. We are excited that the city of Lehi and Geneva Rock were able to collaborate on this successful public/private partnership."

Jay Ritchie, president of Geneva Rock, sees the donation as another way to accomplish his company's mission of building a better community.

"Additional trails up along the hills and foothills will give residents places to exercise, walk their dogs, enjoy the evenings or early mornings and generally have more enjoyment of the community," he says. "We're greatly honored to help provide an amenity which will benefit all the residents who live in that area. Building a better community is one of the tenets by which we operate, and we will continue rehabilitating the land we use to create useful living, working, growing, and playing environments."

Geneva Rock's mission aligns perfectly with the mission

of TMTA. TMTA has been instrumental in the funding and building of multiple trails in Utah, including Sensei (5 miles) built in 2017, Mo-mentum (2.5 miles), LoLo Loop (2.5 miles) built in 2019, Tráverse Travérse (2 miles) built in 2020, and Brookside (in progress). The association has also recently received funding to build Footloose (3 miles), a hiking trail, this year.

"Our newest donation for \$160,000 from Geneva Rock is our biggest yet and TMTA is ecstatic," said Lori Le, president of TMTA. "This is a huge boost in continuing to build trails and will directly fund the continued buildout on Traverse Mountain Trails System."

This build out includes downhill mountain biking trails, hiking trails, multi-use trails, special features, and trailhead improvements.

The demand for natural trails has grown in recent years as more Utahns recognize the benefits of outdoor recreation.
